

# Town Hall Sessions Scheduled for Federally Mandated Provider Re-Enrollment Process

Information posted May 22, 2016

Reminder: Texas Medicaid must comply with federal regulations that require all providers to resubmit their enrollment information every three to five years. In accordance with this mandate, the Centers for Medicare & Medicaid Services (CMS) require that states complete the initial re-enrollment of all providers by March 24, 2016.

Texas Medicaid providers that enrolled *before* January 1, 2013, must be fully re-enrolled by March 24, 2016. This requirement applies to those providing services through Medicaid managed care organizations or through traditional fee-for-service Medicaid.
