On January 1, 2016, TMHP will apply the 2016 annual Healthcare Common Procedure Coding System (HCPCS) updates that are effective for dates of service (DOSs) on or after January 1, 2016. Deleted procedure codes will no longer be benefits of Texas Medicaid or the Children with Special Health Care Needs (CSHCN) Services Program. Prior authorizations that contain one of these discontinued procedure codes: D9221, D9220, G0154, E0450, E0460, E0461, E0463, or E0464, and that include DOSs on or after January 1, 2016, will be honored through the approved authorization period. Providers are required to submit valid procedure codes with every claim.

Benefit changes related to HCPCS 2016 updates will be published in a special bulletin in January 2016.
