Reminder: Effective April 26, 2019, changes will be made to the Sterilization Consent Form, instructions, and denial letter. These changes will apply for all providers that use the Sterilization Consent Form. Failure to use the updated Sterilization Consent Form on or after October 24, 2019, might result in denial of sterilization claims. Any submissions of the previous version of the form after this date will result in a final denial.
