For claims submitted by ambulatory surgical center facilities with dates of service from July 20, 2017, through June 13, 2019, some procedure codes for services may have been reimbursed incorrectly with an additional 5.2 percent of the established Medicaid fee.

Ambulatory surgical centers that were overpaid may have overpayments deducted from future payments (i.e., recouped). Adjustments will be reflected on future Remittance and Status reports.

5 (08/09/19 through 08/30/19) ***Attention All Medicaid Providers*******

Effective for dates of service on or after August 1, 2019, procedure code J1640 is payable only when submitted with diagnosis code E8021 (acute intermittent hepatic porphyria).

Additionally, effective August 1, 2019, there will no longer be an age restriction for procedure code J1640.

Effective September 1, 2019, program providers currently required to use Electronic Visit Verification (EVV) must submit claims for EVV-relevant services, with dates of service on or after September 1, 2019, to TMHP through TexMedConnect or Electronic Data Interchange. This applies to both fee-for-service and Medicaid managed care claims.

Effective July 2, 2019, for dates of service on or after October 1, 2018, Clinician-Administered Drugs procedure code J0606, Parsabiv, is no longer a benefit of Texas Medicaid.

Affected claims, if any, identified with dates of service on or after October 1, 2018, will deny as part of another service.

Providers are not required to appeal the claims unless they are denied for additional reasons after the claims reprocessing is complete.
