There is an update to the article titled "Coming Soon: SUD Treatment Providers Using CMBHS System Can Submit Prior Authorization Requests and Claims Directly to TMHP," which was published on the TMHP website on July 3, 2019. The Texas Health and Human Services Commission (HHSC) has delayed implementation of the SUD Treatment providers using Clinical Management for Behavioral Health Services (CMBHS) system ability to submit prior authorization requests and claims to TMHP. Providers currently submitting Substance Use Disorder (SUD) treatment prior authorization request and claims should continue to use TMHP's Prior Authorization on the Portal to submit claims as usual. HHSC will provide additional information in the future regarding the deployment delay.

9 (08/30/19 through 09/20/19) ***Attention All Medicaid Providers*******

Effective for dates of service from October 1, 2019, through September 30, 2020, the Federal Medical Assistance Percentage (FMAP) will change from 58.19 percent to 60.89 percent. The FMAP change affects only providers that certify expenses and are paid only the federal share of their claims. For these providers, reimbursement will be increased to match the change in the FMAP.

Effective for dates of service from October 1, 2019 through September 30, 2020, the Enhanced Federal Medical Assistance Percentage will change from 93.73 to 84.12 percent. This change will not affect provider reimbursement.

In June, Mylan issued an alert on the manufacturing challenges involved in the production of EpiPen (epinephrine injection, USP) 0.3 mg, EpiPen Jr (epinephrine injection, USP) 0.15 mg Auto-Injectors, and the authorized generic versions of these products. These manufacturing challenges resulted in the reduced availability of these products.

On October 1, 2019, TMHP will implement the third quarter 2019 Healthcare Common Procedure Coding System (HCPCS) additions, revisions, and discontinuations, which will be effective for dates of service on or after October 1, 2019. Discontinued procedure codes will no longer be considered benefits of Texas Medicaid. Added procedure codes will not be reimbursed until the codes are reviewed and a rate hearing is held. Providers will be notified in a future article of any changes in benefits.

For clinician administered drug procedure codes included in a quarterly HCPCS update and approved to be added as Medicaid benefits by HHSC, the rate may be effective as of the Centers for Medicare & Medicaid Services effective date.

For claims submitted by ambulatory surgical center facilities with dates of service from July 20, 2017, through June 13, 2019, some procedure codes for services may have been reimbursed incorrectly with an additional 5.2 percent of the established Medicaid fee.

Ambulatory surgical centers that were overpaid may have overpayments deducted from future payments (i.e., recouped). Adjustments will be reflected on future Remittance and Status reports.
