Effective for dates of service on or after January 1, 2023, claims submitted for procedure code J2020 for Zyvox (linezolid) for the unused portion and discarded portion of weight-based or variable dosing clinician-administered drugs (CADs) manufactured only in single-dose vials, must include the modifier JW for consideration of reimbursement. The JW modifier identifies the unused portion and discarded portion of the vial contents.

Effective for dates of service from January 1, 2023, through March 31, 2023, the Federal Medical Assistance Percentage (FMAP) will remain at 66.07%. This change affects only providers that certify expenses and that are paid only the federal share of their claims.

Effective for dates of service from January 1, 2023, through March 31, 2023, the Enhanced Federal Medical Assistance Percentage (EFMAP) will remain at 76.25%. This change will not affect provider reimbursement.

Beginning January 1, 2023, Texas Medicaid will designate one medication as the primary preferred direct-acting antiviral (DAA) drug option for treating hepatitis C infection. The Texas Health and Human Services Commission (HHSC) will designate all other DAA drugs on the Medicaid formulary as nonpreferred. Also, HHSC will retire two clinical prior authorization forms for hepatitis C treatment agents.

Effective March 1, 2020, through January 31, 2023, to help ensure continuity of care during the COVID-19 (coronavirus) response, the Texas Health and Human Services Commission (HHSC) is authorizing Healthy Texas Women (HTW) providers to bill procedure codes with modifier 95 for medical (physician-delivered) evaluation and management services delivered by telephone (audio-only).

The revised age criteria are for persons 2 years of age or older with psoriatic arthritis.
