The Texas Health and Human Services Commission (HHSC) and Texas Medicaid & Healthcare Partnership (TMHP) have assumed enrollment processing for the Vendor Drug Program (VDP) through the TMHP Provider Enrollment and Management System (PEMS).

The VDP requires that pharmacies validate their license information to ensure that they are up to date and in compliance with Texas Medicaid enrollment policies. License validation includes the type of license and correct pharmacy license number and dates. These are licenses for the pharmacies, not the pharmacist.
