Effective June 28, 2021, Opioid Treatment Providers (OTPs), also referred to as narcotic treatment programs, can access a new Static Fee Schedule that will contain all procedure codes payable to the OTP provider type. The new fee schedule will be available on the Static Fee Schedule page on the TMHP website and will be titled "Outpatient Behavioral Health - Opioid Treatment Provider." The new Static Fee Schedule was created to clarify allowable billing codes for OTPs. It does not change the rates for these billing codes.

Effective for dates of service from July 1, 2021, through September 30, 2021, the Federal Medical Assistance Percentage (FMAP) will remain at 68.01 percent. The FMAP change affects only providers that certify expenses and are paid only the federal share of their claims.

Effective for dates of service from July 1, 2021, through September 30, 2021, the Enhanced Federal Medical Assistance Percentage (EFMAP) will remain at 77.61 percent. This change will not affect provider reimbursement.

Procedure code 90697 is informational only for Medicaid, Texas Health Steps, and the CSHCN Services Program. Vaxelis will be available and distributed to providers free of charge through the Texas Vaccines for Children Program.

When the claims are reprocessed, providers may receive additional payment, which will be reflected on Remittance and Status Reports.
