Proprietary System Operator or PSO: A program provider or FMSA that has been approved by HHSC to use an EVV proprietary system instead of an EVV vendor system from the state vendor pool.

Approved Proprietary System: The EVV proprietary system which HHSC has approved for use by the PSO.

In-House or COTS: Indicates whether the Proprietary System Undergoing ORR has been developed "in-house" or by a software company (Commercial-off-the-Shelf).

Business Rules Version: The version of the HHSC EVV Business Rules for Proprietary Systems that HHSC last used to validate the functionality of the Approved Proprietary System.

Go-Live Date: The date the PSO began using the system in production.

Agency Model: The Approved Proprietary System supports the agency service delivery model.

Consumer Directed Services: The Approved Proprietary System supports the Consumer Directed Services (CDS) delivery model.

Landline: The Approved Proprietary System uses a Member's home landline for clocking in and clocking out.

Alternative Device: The Approved Proprietary System uses an alternative device/method for clocking in and clocking out.

Mobile: The Approved Proprietary System uses a mobile application for clocking in and clocking out.

Provider Web Services: The Approved Proprietary System accesses the HHSC Provider Web Services to verify agency enrollment data.

Authorization Web Services: The Approved Proprietary System accesses the HHSC Authorization Web Services to retrieve prior authorizations for Acute Care and Long Term Care enrolled individuals.

Payer/Plan Code Web Services: The Approved Proprietary System accesses the HHSC Payer/Plan Code Web Services to verify client's associated payer/plan code eligibility.

Client Eligibility: The Approved Proprietary System accesses the HHSC system to verify client Texas Medicaid eligibility.

Daily Fixed Schedule: A Schedule Type feature in the Approved Proprietary System that a System User may choose to plan Member Service visits.

Daily Variable Schedule: A Schedule Type feature in the Approved Proprietary System that a System User may choose to plan Member Service visits. Weekly Variable Schedule: A Schedule Type feature in the Approved Proprietary System that a System User may choose to plan Member Service visits.

Alternate Schedule Type: A Schedule Type feature defined by the PSO in the Approved Proprietary System that a System User may choose to plan Member Service visits.

Expanded Time for Auto-Verification: An optional visit maintenance reduction solution offered to System Users for use with Daily Variable and Daily Fixed Schedules.

Automatic Downward Adjustment: An optional visit maintenance reduction solution offered to System Users for use with Daily Variable and Daily Fixed Schedules.
