6 (01/07/22 through 01/28/22) ***Attention All Medicaid Providers*******

On December 9, 2021, the U.S. Food and Drug Administration (FDA) amended the emergency use authorization (EUA) for the Pfizer-BioNTech COVID-19 vaccine to approve a booster dose for persons 16 and 17 years of age. Additionally, starting December 13, 2021, Pfizer is expected to begin distributing a new formulation of the multiple-dose Pfizer-BioNTech COVID-19 vaccine that does not require dilution.

The Texas Health and Human Services Commission (HHSC) is updating pharmacy benefit coverage for the Pfizer-BioNTech COVID-19 vaccine.

9 (12/17/21 through 01/07/21) ***Attention All Medicaid Providers*******

On November 19, 2021, the U.S. Food and Drug Administration (FDA) amended the emergency use authorizations (EUA) for both the Moderna and Pfizer-BioNTech COVID-19 vaccines. allowing use of a single booster dose for all individuals 18 years of age or older. On November 29, 2021, the Centers for Disease Control and Prevention (CDC) recommended that everyone age 18 or older should get a booster dose six months after their initial Pfizer-BioNTech or Moderna series or two months after their initial Janssen/Johnson & Johnson vaccine.

Effective for dates of service from October 1, 2021, through March 31, 2022, the Federal Medical Assistance Percentage (FMAP) will remain at 67.00 percent. The FMAP affects only providers that certify expenses and are paid only the federal share of their claims.

Effective for dates of service from October 1, 2021, through March 31, 2022, the Enhanced Federal Medical Assistance Percentage (EFMAP) will remain at 76.90 percent. This will not affect provider reimbursement.

Effective December 3, 2021, the U.S. Food and Drug Administration (FDA) revised the emergency use authorization (EUA) of bamlanivimab and etesevimab (previously authorized for pediatric patients 12 years and older weighing at least 40 kilograms, or about 88 pounds) to additionally authorize bamlanivimab and etesevimab administered together for the treatment of mild to moderate COVID-19 and post-exposure prophylaxis in all younger patients, including newborns, who have a positive COVID-19 test and are at high risk for progression to severe COVID-19, including hospitalization or death.

The Texas Health and Human Services Commission (HHSC) was made aware that Ferring Pharmaceuticals has issued a voluntary recall for all batches of its product called Stimat® (desmopressin acetate) Nasal Spray, 1.5mg/ml. The product is currently on the U.S. Federal Drug Administration national drug shortage list, and the manufacturer estimates that Stimat® will not become available until the second half of 2023.
