On April 1, 2022, Texas Medicaid & Healthcare Partnership (TMHP) will implement the first quarter 2022 Healthcare Common Procedure Coding System (HCPCS) additions, revisions, and discontinuations, which will be effective for dates of service on or after April 1, 2022. Discontinued procedure codes will no longer be considered as benefits of Texas Medicaid. Added procedure codes will not be reimbursed until the codes are reviewed and a rate hearing is held. Providers will be notified of any benefit changes in a future article.

For clinician administered drug procedure codes included in a quarterly HCPCS update and approved to be added as Medicaid benefits by the Texas Health and Human Services Commission (HHSC), the rate may be effective as of the Centers for Medicare & Medicaid Services (CMS) effective date.
