This is a reminder that all providers of laboratory services must comply with the rules and regulations of the Clinical Laboratory Improvement Amendment (CLIA). Providers must submit their CLIA certifications and can bill only for services for which they have an appropriate CLIA certification on file. Providers that do not comply with CLIA are not reimbursed for laboratory services.

Diagnosis codes R1111 and R1110 are appropriate and should be used when submitting claims with procedure codes 92517, 92518, and 92519.

Signature requirements for Title XIX (Medicaid) Home Health Services have recently changed. Medicaid-enrolled physicians and allowed practitioners can now sign prior authorizations and order covered Medicaid Home Health Services, including skilled nursing, home health aide services, durable medical equipment and supplies, and adult physical and occupational therapy services.

On November 9, 2022, the Texas Health and Human Services Commission (HHSC) will implement the clinical prior authorization criteria updates for Orkambi (lumacaftor/ivacaftor). The U.S. Food and Drug Administration (FDA) has approved Orkambi for children one year through two years of age with cystic fibrosis with two F508del mutations. This change follows the recent approval for age expansion.

Beginning November 1, 2022, interim claims for School Health and Related Services (SHARS) physical therapy (PT), occupational therapy (OT), speech therapy (ST), and audiology services will be rejected if the billing provider does not include the referring or prescribing provider's National Provider Identifier (NPI) on the claim.
