Reminder: Hospitals or facilities that bill Children with Special Health Care Needs (CSHCN) Services Program claims on the CMS-1450 institutional claim form or electronic equivalent using their hospital or facility national provider identifier (NPI) and taxonomy code for inpatient services will always require authorization.

Requests for emergency hospital admissions must be received by the next working day after the admission date for the coverage of the entire hospital stay. Requests for emergency admissions received after the next business day will be denied for the entire hospital stay.

Physicians who bill CSHCN Services Program claims on the CMS-1500 professional claim form or electronic equivalent using their physician NPI and taxonomy code are not required to obtain prior authorization for inpatient hospital physician evaluation and management (E/M) services.
